* Welcome to Pfadfinderdorf Zellhof! The Zellhof team consists of volunteer members of the Scouting movement, come from many different countries, and are always willing to assist you in your needs. The team is available to you at the kiosk.

General

* The camp rules, the child protection and nature protection laws of the Salzburg region, and the nature protection orders for the Trumer lake region must be observed by all camp participants.

* The camp rules are available in many languages on www.zellhof.at and are also available in the kiosk. In case of disagreement, the German language version prevails.

* Every group must nominate an adult (at least 18 years) group leader, who takes responsibility for the participants and visitors to the group for the duration of their stay and for compliance with the camp rules. Pfadfinderdorf Zellhof takes no responsibility for supervising camp participants or visitors.

* Claims of damages from camp participants and visitors against Pfadfinderdorf Zellhof are excluded to the extend permitted by law.

* Pfadfinderdorf Zellhof takes no responsibility and no liability for the loss, theft or damage of items and valuables of camp participants and visitors.

* The use of all facilities of Pfadfinderdorf Zellhof, particularly sports fields, swimming area, programme facilities, fields, hall, central campfire area, etc. is at own risk.

* The parking of vehicles and the use of the parking place is at own risk. Pfadfinderdorf Zellhof takes no responsibility and no liability for damage or losses from vehicles.

* In the case that the camp rules are not followed, Pfadfinderdorf Zellhof has the right to forbid groups or individuals from the site.

* For all disputes in connection with Pfadfinderdorf Zellhof, the court of jurisdiction is to be Salzburg.

* Each group should bring their own first aid supplies, appropriate to the size of their group.

Activities at Zellhof

* The Zellhof wood is available for activities. Please stay on the paths and do not go into the forest at sunrise and at sunset (our wild animals wish to graze in peace). The wood and the meadows south of the main road are nature reserves and must not be entered.

* Outside the campsite, please stay on walking paths and do not go through high grass, as the farmer uses this grass for animal food.

* Radios may only be played at a volume where the sound cannot be heard outside of the tent or room.

* Pfadfinderdorf Zellhof lies directly on the Grabensee lake. Please follow the swimming and boating rules which can be found in the kiosk and on www.zellhof.at. The use of the swimming area and of boats is at own risk. Each group must provide for its swimmers a competent adult lifeguard. All water activities are only permitted between 7 am - 8 pm. Surfing, sailing boats and rafts are not permitted in the Grabensee.

* Please pay attention to the storm warning light on the Waschhaus building. In the case of a storm warning, all activities on the lake must cease immediately and preparations should be made on your campsite.

* Flachgau is located in a TBE risk area. TBE is a viral infection transmitted by ticks. Therefore, a tick vaccination is recommended for all camp participants.

Your stay at Zellhof

* Rubbish separation: A recycling station can be found next to the kiosk. Please separate out all rubbish at your campsite and avoid unnecessary packages and wrapping.

* Please do not bring any alcohol with you. Beer and wine can be purchased at the camp store - Hard liquor like vodka, brandy etc. are not allowed at Zellhof.

* Dogs are not allowed at Pfadfinderdorf Zellhof.

* Any damages must be paid by the group. Please notify them as soon as possible, so we can carry out repairs.

- * Camp quiet times are from midnight until 7 in the morning.
- * Please keep the houses and the campsite tidy and turn them over in a clean state to the Zellhof team before departure.

Especially Camp site

- * Pfadfinderdorf Zellhof lies in the middle of a nature preserve. Please do not make sump pits and no drainage canals (Dams are a better option).
- * Fireplaces must either be built high off the ground or on earth to a height of at least 20 cm put underneath. Each group must be responsible for safe practice and observation of cooking fires and camp fires, and must have an extinguisher (fire blanket, fire extinguisher, bucket of water etc.) provided by themselves ready in case of emergencies.
- * Camping groups can take their drinking water from the Rossstall. Running hosepipes for water to the campsite is not possible.
- * Running electricity cables to the campsite, or the use of electricity generators, is not possible.
- * Communal areas such as toilets, washing facilities, etc. are cleaned by the groups each day on a rota system, please bring your own cleaning liquids.
- * Each group is responsible for the safety of their camp constructions, the testing of materials used, and their demolition.

Especially Self Catering Houses

- * Eating and drinking are only permitted in the ground level of each house.
- * Smoking is not permitted in our self-catering houses.
- * Indoor tables, benches and chairs should stay in the house. If you need tables and benches for outside, we can provide them.
- * Our beds are only fitted with mattresses and mattress protection sheets. Please bring your own sheets and sleeping bags. Sheets, blankets, pillows, and pillowcases can be borrowed but will cost extra.
- * Energy will be paid for according to use - Conservation is worthwhile!
- * On your day of departure, please clean the house and hand it over to the Zellhof Team until 12 a.m. noon. Check-in is possible starting 3 p.m.
